

Responsive to your letter of April 3 concerning my dual service on the Board of Adjustment and the Gainesville Human Rights Board, if a mistake has been made it is a mistake made by the City, not me. In late 2011, I applied for a position on one or the other of the two boards (there were, at the time, openings on both), and the City saw fit to appoint me to both boards. Now, roughly two and one-half years later you or your staff has, apparently, discovered the City's error. As a result, you say I am "required" to resign from one of those boards.
