General Manager Outstanding Referral Status Report

Following is a list of each item and a brief description of the status of the referrals to the General Manager:

1. #040091 – Utility Downtown Operation Center Redevelopment:

At the June 15, 2004 meeting the City Commission referred the issue of developing an exit and redevelopment plan for the Utility Downtown Operation Center to the General Manager and City Manager. This is an on-going project and will be retained on the General Manager's referral list.

2. #040177 - Final Report of the Ad Hoc Affordable Housing Committee:

At the June 13, 2005 meeting the City Commission referred to the General Manager and City Manager the issue of developing an implementation plan with a report back to the City Commission. On December 12, 2005, the final report of the Ad Hoc Committee was presented to the Commission. The Commission authorized the Mayor to write a letter to the University of Florida seeking their implementation of an employee home purchase assistance program in areas nearby the University. The Commission also referred to the Community Development Committee the following issues: 1) Energy Efficiency standards for landlords for rental units as part of the qualifications for Section 8 re-reimbursements; and 2) investigate incorporating energy requirements as part of the City of Gainesville minimum housing code. This item can be removed from the General Manager's referral list.

3. #051011 - Reverend Dr. Aaron Young - Victory Temple Church of God In Christ:

At the February 27, 2006 meeting the City Commission referred to the General Manager the issues of Dr. Aaron Young with a report back to the City Commission at a future meeting. This item will be retained on the General Manager's referral list.
