SUBJECT: City Commission Referrals to the Regional Utilities Committee

Following is a list of each item and a brief description of the status of the referrals to the Regional Utilities Committee (RUC):

1. **#040737 – RFP for Conservation Services:**

On November 22, 2004 the City Commission referred to the Regional Utilities Committee the issue of whether there are deterrents to free market competition and how to address that. Staff responded to this referral at the City Commission meeting of December 13, 2004 as part of agenda item #040766 entitled "Follow-up on Long Term Electrical Supply Plan." The response was included in the document submitted as backup. Remove this item from the Regional Utilities Committee referral list.

2. **#04240 – Fire Hydrant Fees:**

The issue of Fire Hydrant Fees was brought forward at the July 22, 2004 GRU budget presentation by Commissioner Braddy and to the Regional Utilities Committee. The issue was discussed at the 8/19/04, 10/14/04 and 11/18/04 Regional Utilities Committee meetings. At the direction of the Regional Utilities Committee staff made a presentation to the City Commission on January 24, 2005. The City Commission instructed staff to present Option 2 (from the City Manager's memo) during FY 2006 budget hearings and the Commission shall consider whether or not to move forward with the proposal after hearing recommendations from staff. On February 14, 2005 the City Commission voted to add this topic to the agenda for the Joint City/County Commission meeting scheduled for March 10, 2005. The Regional Utilities Committee will retain this item.

3. **#031090 – Airport Solar Project:**

On March 29, 2004 the City Commission referred the issue of developing an increased implementation of a photovoltaic rooftop system on the Gainesville Regional Airport Terminal to the Regional Utilities Committee. The RUC will consider this item at its March 3, 2005 meeting.

5. **#031086 – Utilities Policies to Promote Residential Grid-Connected Solar Electric Systems (Mayor Tom Bussing):**

On March 29, 2004 the City Commission referred the issue of developing residential photovoltaic policies including 1) inspection charges; 2) payment for electricity that is run back into the grid system; 3) utility policies that actually promote the installation of these residential grid connected photovoltaic systems that would reduce the fees for inspecting the system and take on more of those costs onto the utility as a research project. The RUC will consider this item at its March 3, 2005 meeting.

6. **#020285 – Airport Solar Electric Project:**

On July 16, 2001 the City Commission referred the issue of a potential photovoltaic application at the Airport. Staff gave several informal updates on the status of the Airport panel item. On April 23, 2003 the RUC heard a formal presentation on the work staff has been doing with Gainesville Regional Airport staff to coordinate the installation of a solar electric system with renovations currently being considered at the airport. Airport staff has been working with a planner/architect to perform a needs assessment for this facility. GRU staff will continue to work with the Airport staff and their planner to assure the proposed solar electric system is integrated into the facility as a master plan is developed. The RUC will consider this item at its March 3, 2005 meeting.

On September 24, 2001 the City Commission heard a report from the Water Management Advisory Committee recommending that the Commission adopt the GRU Reuse Extension plan as presented to the Water Management Committee.
