COMPLAINT

The Plaintiff, Betty Long, sues Defendant, Gainesville Regional Utilities; a utility owned by the City of Gainesville, Florida, and alleges the following:

- 1. This is an action for damages in excess of \$15,000, exclusive of interest and costs.
- Defendant, Gainesville Regional Utilities (GRU), is a utility owned by the City of Gainesville, Florida with its headquarters in Gainesville, Alachua County, Florida.
- 3. Plaintiff, Betty Long (Long), is a resident of Alachua County, Florida.
- 4. On or about September 2, 2005, Long was a customer of GRU.
- 5. On the above date, Long went to the GRU administrative office located at 301 S.E. 4th
 Avenue in Gainesville, Alachua County, Florida for the purpose of paying her bill.
- 6. Long entered the GRU facility and paid her bill.
- After exiting the GRU facility, Long attempted to descend the stairs outside of the GRU building, on premises controlled by GRU.
- 8. As she attempted to descend the stairs, Long was a business invitee of GRU within the

meaning of Florida statutes and ease law, as she had come upon the GRU premises for the purpose of conducting business with GRU.

- 9. As she attempted to descend the stairs, Long slipped and fell down the stairs.
- 10. GRU owed to Long, a duty of exercising reasonable care in keeping its premises in a reasonably safe condition and of warning Long of hidden dangers of which GRU was aware or which had been in existence for such a period of time that GRU reasonably should have been aware of them, had GRU been reasonably careful, and which were not open and obvious to Long.
- 11. GRU breached its duty of care to Long in ways including, but not limited to the following:
 - a. GRU allowed the steps, which were constructed of bricks, to become unreasonably slippery due to an accumulation of a slick substance that was green in color and appeared to be moss;
 - b. GRU allowed the only handrail in the vicinity to become so loose that it would not assist one in descending stairs and actually threatened to come out of its moorings and become a danger to anyone using it;
 - c. GRU did not have a sufficient number of handrails on its stairs in the vicinity of Long's fall, thereby leaving a large area of stairs with no handrails for pedestrians to grasp while using the stairs;
 - d. GRU did not place a traction device on the stairs, under circumstances where such device would be necessary to prevent the stairs from becoming unreasonably slippery;
 - e. GRU did not warn of the slippery nature of the stairs; and

- f. Other acts and omissions of negligence.
- 12. As a result, Long suffered bodily injury and resulting pain and suffering, disability, disfigurement, mental anguish, loss of capacity for the enjoyment of life, expense of hospitalization, medical and nursing care and treatment, loss of earnings, loss of ability to earn money, and aggravation of a previously existing condition. The losses are either permanent or continuing and Long will suffer the losses in the future. Long suffered a permanent injury within a reasonable degree of medical probability.
- 13. Long has satisfied all conditions precedent to filing this action, including but not limited to the notice provisions of 768.28, Florida Statutes, or Defendant has waived such conditions.
 Copies of proof of notice to both Defendants is attached as Composite Exhibit A.
- 14. Section 768:28, Florida Statutes creates a limited waiver of sovereign immunity by Defendants for negligence actions such as this.

WHEREFORE, Plaintiff, Betty Long demands judgment for damages, pre-judgment interest and costs against Defendant. Gainesville Regional Utilities, and demands trial by jury on all issues so triable.
