# **120722.** Strategic Initiative 6.5: Recreation Master Plan (B)

This item provides funding alternatives for the Parks, Recreation and Cultural Affairs Master Planning Process.

This item was introduced by Assistant City Manager Paul Folkers. Michelle Park, Assistant Director of Gainesville Parks, Recreation and Cultural Affairs presented several potential funding options to the committee members (maintain the same level of funding, dedicated millage rate increase, county-wide sales tax similar to Wild Space Public Places, and bonding). Finance Director Mark Benton led a discussion with details on the various funding options.

Michelle Park distributed hand-outs indicating a one-time fee increase (10% surcharge to be set aside in a Recreation Master Plan account). The surcharge could be used to pay for a Partnership & Development Coordinator to solicit

corporate sponsorships and contributions, as well as write grants. The Coordinator could be either a sub-contractor/fund raiser working for a percentage of the funds raised or a salaried employee of the City of Gainesville. This recommendation, as well as a differential pricing strategy to vary prices by weekday and weekend facility rental, will be discussed during the budget presentation in July. Staff recommended to the Committee members that the trails and bikeway components of the Master Plan (almost \$8 million) be considered for inclusion in the 2014 Transportation Infrastructure surtax proposed.

The fees (not the funding sources) will be presented during the budget process. More discussion is needed in Committee about the funding sources before bringing it before the full City Commission.

RECOMMENDATION

The Recreation, Cultural Affairs and Public Works
Committee discuss the funding scenarios for the Parks,
Recreation and Cultural Affairs Master Plan and provide staff
direction for future action.
