4 In order to provide funds for the costs of maintaining cemetery grounds and
5 furnishing cemetery services, prices for spaces and charges for services will be adjusted
6 periodically, based on review and analysis of local market rates and thereafter set forth in
7 Appendix A and will thereafter be adopted by resolution of the city commission.

3 **Section 4.** If any word, phrase, clause, paragraph, section or provision of this
4 ordinance or the application hereof to any person or circumstance is held invalid or
5 unconstitutional, such finding shall not affect the other provisions or applications of the
6 ordinance which can be given effect without the invalid or unconstitutional provisions or
7 application, and to this end the provisions of this ordinance are declared severable.

8 **Section 5.** All ordinances, or parts of ordinances, in conflict herewith are to the
9 extent of such conflict hereby repealed.

10 **Section 6.** This ordinance shall take effect immediately upon adoption.




