Implementation Committee, County Manager and City Manager Joint
Recommendations

- IV. City and County Commission approve the following recommendations from the Homeless Implementation Committee, City Manager and County Manager.
 - (a) Accept the Revised Logic Model as the Blue Print for Implementation of the GRACE 10-Year Plan to End Homelessness.
 - (b) Accept the short term goals and objects for implementation as outlined in the Logic Models and accept the recommendations below as priority for funding from the funds allocated by the City, County and Clark Butler.

(c) Provide funding for the Office of Homelessness and hire the Homeless Administrator to serve as the coordinator for implementing the GRACE 10-Year Plan to End Homelessness full time by October 1, 2006 as recommended by the Implementation Committee. And, approve an extension of the current inter-local agreement between the City, County and Alachua County Housing Authority in the amount of up to \$36,000.00 per year for two years for a total of \$72, 000.00 to be funded equally by the City and County Commission.

(d) Provide funding for the case management-centered one-stop assistance center, as defined by the Implementation Committee. The City and County Commission authorize the office on Homelessness to issue an RFP to rent space for the one-stop center and that it start on a smaller scale with a first year budget of \$175,618 to be funded equally by the City and County Commission.

(e) The City and County Commission set-a-side funds to match State and Federal grants for implementing the GRACE 10-Year Plan to End Homelessness as follows: The City of Gainesville, \$43,698.79 and Alachua County, \$40,000.00

(f) The Donation of \$100,000.00 from Mr. Clark Butler to the County Commission be allocated for future implementation of the 10 Year Plan to End Homelessness when recommended by the Implementation Committee, County Manager and City Manager and approved by the County Commission.
