## CITY OF GAINESVILLE, FLORIDA COMMUNITY REDEVELOPMENT AGENCY RULES OF PROCEDURE

Three terms of three years expiring on June 17, 1998/2001/2004

Two terms of two years expiring on June 17, 1997/2000/2003

Two terms of one year expiring on June 17, 1996/1999/2002

Board members are subject to the City Commission attendance policy as follows:

If a board member fails to attend four (4) or more consecutive meetings, or that the overall attendance record of the member is less than sixty-six and two-thirds (66 2/3 %) percent for any six (6) month period, then the board member is automatically removed from the Board upon the filing of the attendance record(s) with the Clerk of Commission indicating the failure of the board member to meet the attendance requirements. Attendance means presence at the meeting no later than fifteen (15) minutes after the meeting is called to order as verified by the Secretary on the attendance record.

Board members shall serve at the pleasure of the CRA and may be removed upon the recommendation of the Executive Director, or by any other action of the CRA.

Advisory boards shall not create committees thereof without prior approval by the Community Redevelopment Agency.

All advisory boards shall submit their guidelines and procedures to the Community

Redevelopment Agency for approval prior to such guidelines and procedures or changes thereto becoming effective.

The guidelines and procedures for each Advisory Board will be attached to the Community Redevelopment Agency's Rules of Procedure.

Each advisory board's guidelines and procedures will be outlined in articles in the following order:
