NOTICE 1030924 Fees Charged for use of the City's Athletic Fields (NB)

Explanation: The City Commission referred this matter to the Recreation and Cultural Affairs Committee (RCA) in February 2004. This matter consisted of two separate policies on athletic field usage fees. The first was a new fee of \$20 being charged by the Recreation and Parks Department to non-city league teams for the use of the ball fields at Westside and Greentree Parks. This new fee was in addition to the existing \$20 lighting charge that had been in place since the early 1990's. The second issue involved the charges to the Gainesville Girls Fastpitch Softball for the use of Northeast Park.

The first matter of the additional \$20 fee to non-city league teams was discussed and a resolution arrived during the April 22, 2004 RCA meeting. The City will not implement this additional \$20 field fee; however, the original \$20 lighting fee will be kept and the fields being utilized by outside teams will be rotated. Field rotation will give the fields time to rest during the regular and off-season, thus enhancing the playing experience.

The second matter of the Girls Softball fees was referred back to the Recreation and Parks Department and the Girls Softball organization to work together on forming a partnership to run the girls Fastpitch program in future seasons. Upon agreement, a report will be made back to the City Commission.

Fiscal Note: None can be determined at this time.

RECOMMENDATION The City Commission approve the recommendation on

the field rotation concept, and await a

recommendation from the RCA on the Girls Fastpitch

Softball fees at a later date.
