18 **WHEREAS**, the Board of Canvassers has now reported that Craig Carter received the
19 majority of votes cast for the District 3 Seat in the election; and

20 **NOW, THEREFORE**, BE IT RESOLVED BY THE CITY COMMISSION OF THE
21 CITY OF GAINESVILLE, FLORIDA:




Annie Orlando

Craig Carter received the majority of the votes cast for the District 3 City Commission seat.


