

**ORDINANCE NO. 080026**  
**0-08-30**

**An ordinance amending the City of Gainesville 2000-2010 Comprehensive Plan, Future Land Use Map; by changing the land use category of certain property, as more specifically described in this ordinance, from the Alachua County land use category of “Heavy Industrial” to the City of Gainesville land use category of “Public Facilities”; generally located adjacent to the southern boundary of the Gainesville Regional Airport, and more specifically described as that area comprised of City-owned Tax Parcel 17731-002-000, generally located north of the City limits and Tax Parcel 17732-000-000, east of Tax Parcel 08178-000-000 and 08180-000-000, south and west of Tax Parcel 17730-000-000; providing a severability clause; providing a repealing clause; and providing an immediate effective date.**

**WHEREAS**, publication of notice of a public hearing was given that the Future Land Use Map be amended by changing the land use category of certain property from the Alachua County land use category of “Heavy Industrial” to City of Gainesville land use category of “Public Facilities”; and

**WHEREAS**, notice was given and publication made as required by law and a public hearing was held by the City Plan Board on July 17, 2008; and

**WHEREAS**, the amendment to the land use category of the City of Gainesville 2000-2010 Comprehensive Plan proposed herein directly relates to a small scale development activity as provided in Chapter 163, Florida Statutes; and

**WHEREAS**, the City of Gainesville will transmit copies of the public notice and this proposed ordinance to the State Land Planning Agency, the regional planning council, and any other person or entity who has requested a copy; and

1           **WHEREAS**, at least ten (10) days notice has been given of a public hearing once by publication  
2 in a newspaper of general circulation notifying the public of this proposed ordinance and of a Public  
3 Hearing in the City Commission meeting room, First Floor, City Hall in the City of Gainesville; and

4           **WHEREAS**, pursuant to law, notice has also been given by mail to the owner whose property  
5 will be regulated by the adoption of this Ordinance, at least thirty (30) days prior to the date set for a  
6 public hearing on this ordinance; and

7           **WHEREAS**, the public hearing was held pursuant to the published notice described above at  
8 which hearing the parties in interest and all others had an opportunity to be and were, in fact, heard.

9           **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE**  
10 **CITY OF GAINESVILLE, FLORIDA:**

11           **Section 1.** The Future Land Use Map of the City of Gainesville 2000-2010 Comprehensive Plan  
12 is amended by changing the land use category of the following described property from the Alachua  
13 County land use category of “Heavy Industrial” to the City of Gainesville land use category of “Public  
14 Facilities”:

15                   See legal description attached hereto as Exhibit "A", and made a part  
16                   hereof as if set forth in full.

17  
18           **Section 2.** The City Manager is authorized and directed to make the necessary changes in maps  
19 and other data in the City of Gainesville 2000-2010 Comprehensive Plan, or element, or portion thereof  
20 in order to comply with this ordinance.

21           **Section 3.** If any word, phrase, clause, paragraph, section or provision of this ordinance or the  
22 application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall

1 not affect the other provisions or applications of the ordinance which can be given effect without the  
2 invalid or unconstitutional provisions or application, and to this end the provisions of this ordinance  
3 are declared severable.

4 **Section 4.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of such  
5 conflict hereby repealed.


6 **Section 5.** This ordinance shall become effective immediately upon passage; however, the  
7 amendment to the City of Gainesville 2000-2010 Comprehensive Plan shall become effective thirty one  
8 (31) days after passage and adoption of this Ordinance unless a petition is filed with the Division of  
9 Administrative Hearings pursuant to § 163.3187(3), F.S. In this event this Ordinance shall not become  
10 effective until the state land planning agency issues a final order determining the adopted amendment to  
11 be in compliance in accordance with § 163.3187, or until the Administration Commission issues a final  
12 order determining the adopted amendment to be in compliance in accordance with § 163.3187, F.S.



AREA 2  
PARCEL # 17731-002-000

A TRACT OF LAND SITUATED IN THE SOUTHWEST ¼ OF THE NORTHWEST ¼ OF SECTION 30, TOWNSHIP 9 SOUTH, RANGE 21 EAST ALACHUA COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHWEST CORNER OF SECTION 30, TOWNSHIP 9 SOUTH, RANGE 21 EAST AND RUN SOUTH 00° 17' 40" EAST ALONG THE WEST LINE OF SAID SECTION 2094.288 FEET TO SOUTHWEST CORNER OF TAX PARCEL NUMBER 17732-002-000 AND THE POINT OF BEGINNING; THENCE RUN SOUTH 89° 48' 40" EAST 474.95 FEET TO THE SOUTHEAST CORNER OF TAX PARCEL NUMBER 17732-002-000 AND THE EXISTING CITY OF GAINESVILLE LIMIT LINE; THENCE RUN NORTH 00° 20' 36" WEST 177.272 FEET ALONG THE EAST LINE OF SAID TAX PARCEL AND EXISTING CITY LIMIT LINE TO THE NORTHEAST CORNER OF SAID TAX PARCEL; THENCE RUN NORTH 89° 46' 09" WEST ALONG THE NORTH LINE OF SAID TAX PARCEL AND EXISTING CITY LIMIT LINE 474.95 FEET TO THE WEST LINE OF SAID TAX PARCEL AND THE WEST LINE OF SECTION 30; THENCE RUN SOUTH 00° 17' 40" EAST ALONG SAID WEST LINES AND EXISTING CITY LIMIT LINE AND THE SOUTHERLY EXTENSION THEREOF 178.236 FEET TO THE POINT OF BEGINNING.
