*A presentation on the updates to the solid waste ordinance was given by Michael Heimbach, Sustainability Manager. Katherine Mockler, Assistant City Attorney, and Phil Mann, Director of Public Works, spoke to the item.*

*The subcommittee directed staff as follows: 1) to use city code enforcement proceedings for enforcement of multifamily recycling and container location regulations; 2) create language that allows the city to give an exemption to a commercial entity not providing adequate space for containers; 3) to use city code enforcement proceedings for enforcement of prescription drug take back; 4) eliminate the requirement to provide plastic bag recycling; 5) adjust reuse timelines for Single Family Curbside Analysis and Multi-Family Pilot Program to 2023 implementation.*
