CONSENT

SUBJECT: Terrence Evanich v. City of Gainesville
Alachua County Circuit Court; Case No.: 01-00-CA-3077

Recommendation: The City Commission authorize the City Attorney and/or Special Counsel if insurance coverage is available, to represent the City in the case styled Terrence Evanich v. City of Gainesville, Alachua County Circuit Court, Case Number 01-00-CA-3077.

On September 8, 2000, the City of Gainesville received a Summons and Complaint filed by Terrence Evanich in this action. On July 16, 1999, while operating a lawn mower, Mr. Evanich ran into a GRU transformer. Mr. Evanich alleges that the transformer exploded, knocking him from his mower and rupturing the fuel tank, which caused burns to his body. He alleges that GRU was negligent in the placement of the transformer and in its failure to warn of the danger in coming into contact with the box. Mr. Evanich seeks damages from the City as a result of his injuries.

COMPLAINT

The Plaintiff, TERRENCE EVANICH, sues the Defendant, CITY OF GAINESVILLE,
and says:

1. This is an action for damages which exceed \$15,000 exclusive of interest and costs.
2. The Defendant is the City of Gainesville, a municipal corporation organized under the laws of the State of Florida.
3. At all material times, the Defendant owned and operated a utility system known as Gainesville Regional Utilities ("G.R.U."). Its principal place of business is Alachua County, Florida.
4. On July 16, 1999, Mr. Evanich was an employee of C&R Lawn Service of Gainesville, and was working at the Lexington Apartments located at 3700 Southwest 25th Street, Gainesville, Florida.

5. At said time and place, while operating a lawn mower, Mr. Evanich bumped a large transformer box with the lawn mower, causing an explosion which knocked Mr. Evanich from his mower and ruptured the fuel tank, spreading fire over the ground and Mr. Evanich.

6. The above-described transformer was owned, installed, maintained and operated by GRU, at all times material hereto.

7. At said time and place, the Defendant knew or should have known that its transformer box was in a common area where people traverse, and where lawn maintenance equipment would be operated, and that people and equipment would likely come in contact with it. Contact with the transformer by people and lawn maintenance equipment, was foreseeable to the defendant.

8. At all material times, the Defendant owed a legal duty to the Plaintiff to provide a transformer that was not explosive upon similar contacts and to warn of any hazard of touching the box.

9. At said time and place, the Defendant breached said legal duty to the Plaintiff, in one or more of the following ways:

- a. by leaving in the public lawn area a transformer box that was explosive upon contact with the Plaintiff's lawn mower; and
- b. by failing to warn the Plaintiff of the charged, explosive nature of the box in the lawn area.

10. As a direct and proximate result of this breach of legal duty by the Defendant, the Plaintiff sustained physical and mental injuries; scarring and disfigurement; incurred medical and hospital bills; lost wages and earning capacity; sustained physical and mental pain and suffering; aggravated preexisting injuries and conditions; and lost the capacity to fully enjoy life. All such losses shall continue in the future.


11. The Plaintiff has fully complied with all conditions precedent to initiating this action.

WHEREFORE, the Plaintiff, TERRENCE EVANICH, demands judgment against the Defendant, the City of Gainesville, for damages and costs, and requests a jury trial.
