4	An ordinance of the City of Gainesville, Florida, amending the
5	Zoning Map Atlas and rezoning certain property within the
6	City, as more specifically described in this Ordinance, from the
7	City of Gainesville zoning category of "MH: 12 units/acre
8	mobile home residential district" to the City of Gainesville
9	zoning category of "BUS: General business district"; consisting
10	of approximately 7.5 acres, located in the vicinity of the
11	Southwest corner of Northeast 2 nd Street and 39 th Avenue, a/k/a
12 13	39 N.W. 39 th Avenue; providing a severability clause; providing
14	a repealing clause; and providing an immediate effective date.

16	WHEREAS, by initiation of a petition by the property owner, publication of notice of a
17	public hearing was given that the Zoning Map Atlas be amended by rezoning certain property
18	within the City, as more specifically described in this Ordinance, from the City of Gainesville
19	zoning category of "MH: 12 units/acre mobile home residential district" to the City of
20	Gainesville zoning category of "BUS: General business district"; and
21	WHEREAS, notice was given and publication made as required by law and a public
22	hearing was held by the City Plan Board on May 28, 2009; and
23	WHEREAS, the City Commission finds that the rezoning of the property described
24	herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan, as
25	applicable; and
26	WHEREAS, at least ten (10) days notice has been given of the public hearings once by

publication in a newspaper of general circulation notifying the public of this proposed ordinance

and of a Public Hearing in the City Commission meeting room, First Floor, City Hall, in the City

10	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the
11	following described property from the City of Gainesville zoning category of "MH: 12 units/acre
12	mobile home residential district" to the City of Gainesville zoning category of "BUS: General

16 17	Section 2. The City Manager is authorized and directed to make the necessary changes in
18	the Zoning Map to comply with this Ordinance.

20	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
