**CERTIFICATE MAKING CERTAIN DETERMINATIONS
PURSUANT TO SECTION 18 OF RESOLUTION NO. 061002**

In connection with the execution and delivery on the date hereof of that certain Third Amendment to Standby Bond Purchase Agreement dated as of February __, 2018 (the "Agreement") extending the scheduled expiration date of the Standby Bond Purchase Agreement dated as of March 1, 2007, between the City of Gainesville, Florida (the "City") and State Street Bank and Trust Company (the "Bank"), relating to the City's Variable Rate Utilities System Revenue Bonds, 2007 Series A (the "2007 Series A Bonds"), I, EDWARD J.
