| 19 | WHEREAS, the jurisdiction of Alachua County includes lands located in the Suwannee |
| 20 | River and St. Johns River Water Management Districts; and |
| 21 | WHEREAS, year-round water conservation measures are an integral component of long- |
| 22 | term efforts to preserve and protect water supplies and water resources; and |
| 23 | WHEREAS, a water shortage or water shortage emergency may be declared from time to |
| 24 | time by the Suwannee River and St. Johns River Water Management Districts; and |
| 25 | WHEREAS, during such water shortage condition the amount of surface and |
| 26 | groundwater supplies may become insufficient to meet current or anticipated demands; and |
| 27 | WHEREAS, upon the existence of such conditions it becomes imperative to the public |
| 28 | well-being that certain uses of water be restricted or curtailed and that available water resources |
| 29 | be allocated; and |
| 30 | WHEREAS, the water management districts have primary responsibility under Chapter |
| 31 | 373, Florida statutes, for regulating water use and allocating available water supplies during |
| 32 | periods of water shortage; and |

| 5 | WHEREAS, the Suwannee River and St. Johns River Water Management Districts have |
| 6 | adopted a "Water Shortage Plan," codified as Chapters 40B-21 and 40C-21, Florida |
| 7 | Administrative Code, for the purpose of allocating and conserving the water resource during |
| 8 | periods of water shortage and maintaining a uniform approach towards water use restrictions; and |
| 9 | WHEREAS, the Suwannee River and St. Johns River Water Management Districts have |
| 10 | requested the assistance of Alachua County in the enforcement of the provisions of both the |
| 11 | "Year-Round Water Conservation Measures" and the "Water Shortage Plan"; and |
| 12 | WHEREAS, pursuant to Section 376.046, Florida Statutes, the St. Johns River Water |
| 13 | Management District and the Suwannee River Water Management District are authorized to |
| 14 | enter into an interagency agreement to designate one Water Management District as the agency |
| 15 | with the authority to declare and enforce water shortage emergencies under section 373.175 and |
| 16 | 373.246, Florida Statutes and Chapter 40C-21 F.A.C. within all areas of Alachua County; and |

It is the intent and purpose of this Ordinance to protect the water resources of Alachua County from inefficient use at all times and overutilization during periods of water shortage by assisting the Suwannee River and St. Johns River Water Management Districts in the implementation of their Year-Round Water Conservation Measures and Water Shortage Plans. | | | | | |
| 17 18 19 20 21 22 23 | Sec. 80.2 Definitions. For the purpose of this Ordinance the following terms, phrases, words and their derivatives shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural include the singular, and words in the singular include the plural. The word "shall" is always mandatory and not merely directory. | | | | | |
| 24 25 26 | (a) "District" is the Suwannee River Water Management District or St. Johns River Water Management District. | | | | | |
| 27 28 29 | (b) " <i>Person</i> " is any person, firm, partnership, association, corporation, company, or organization of any kind. | | | | | |
| 30 31 32 | (c) "Water resource" means any and all water on or beneath the surface of the ground, including natural or artificial water courses, lakes, ponds, or diffused surface water, and water percolating, standing, or flowing beneath the surface of the ground | | | | | |

 (d) "Water shortage condition" is when sufficient water is not available to meet present or anticipated needs of persons using the water resource, or when conditions are such as to require temporary reduction in total water usage within a particular area to protect the water resource from serious harm. A water shortage usually occurs due to drought.

(e) "Water shortage emergency" means that situation when the powers which can be exercised under Rules 40B-21.621 through 40B-21.641, or their counterparts in Chapter 40C-21, Florida Administrative Code, are not sufficient to protect the public health, safety, or welfare, or the health of animals, fish or aquatic life, or a public water supply or commercial, industrial, agricultural, recreational or other reasonable uses.

Sec. 80.3 Application of ordinance.

The provisions of this Ordinance shall apply to all persons in unincorporated Alachua County under the jurisdiction of the Suwannee River and St. Johns River Water Management Districts using the water resource for lawn irrigation, landscape irrigation, and related outdoor water uses such as car washing, whether from public or privately owned water utility systems, private wells, or private connections with surface water bodies. Wherever any requirement of this Ordinance conflicts with the requirements of Chapter 79, Alachua County Code, Irrigation Conservation Standards and Management Practices Code, the most restrictive requirement or that imposing the higher standards shall govern unless otherwise specifically provided.

Sec. 80.4 Amendments to year-round water conservation measures and water shortage plan.

All portions of Chapters 40B-21 and 40C-21, Florida Administrative Code, dealing with lawn irrigation, landscape irrigation, and related outdoor water use, as each may be amended from time to time, are incorporated herein by reference as a part of the Alachua County Code of Ordinances.

Sec. 80.5 Applicability of year-round water conservation measures.

In the absence of a declaration of a water shortage or water shortage emergency within all or any part of Alachua County by the Governing Board or the Executive Director of the District, all lawn irrigation, landscape irrigation and related outdoor water conservation measures adopted by the District applicable to Alachua County, or any portion thereof, shall be subject to enforcement action pursuant to this Ordinance. Any violation of the provisions of Chapters 40B-21 or 40C-21, Florida Administrative Code, or any order issued pursuant thereto, shall be a violation of this Ordinance.

Sec. 80.6 Declaration of water shortage; water shortage emergency.

Upon declaration of a water shortage or water shortage emergency within Alachua County by the Governing Board or the Executive Director of the District, all lawn irrigation, landscape irrigation and related outdoor water shortage restrictions adopted by the District applicable within Alachua County, shall be subject to enforcement action pursuant to this Ordinance. Any violation of the provisions of Chapters 40B-21 or 40C-21, Florida Administrative Code, or any order issued pursuant thereto, shall be a violation of this Ordinance.

Sec. 80.7 Enforcement.

The provisions of this chapter may be enforced using the code enforcement board process of Chapter 162, Part I, Florida Statutes, or the civil citation process of Chapter 162, Part II, Florida Statutes, and Chapter 24, Alachua County Code. In addressing residential violations county staff shall provide an educational approach that emphasizes environmental awareness in order to achieve compliance prior to initiating enforcement action with the use of the provisions of Chapter 24.

Sec. 80.8 Penalties.

(a) Violation of any provision of this Ordinance shall be subject to penalties as provided in Section 24.16, Alachua County Code.

SECTION 2. Section 24.05(a), Alachua County Code, is hereby amended to add the

following to the codes within the jurisdiction of the Code Enforcement Board:

(6) Water Conservation (Chapter 80)

 SECTION 3. Section 24.16, Exhibit A, Alachua County Code, is hereby amended to add the following to the schedule of penalties for codes administered by the County's Environmental Protection Department:
