

RESOLUTION NO. 121004

Board of County Canvassers in and for Alachua County, do hereby certify that we met on the **12th Day of April, A.D., 2013**, and proceeded to publicly canvass the votes from the **City of Gainesville Annexation Area 2 & 3 Election held on the 9th day of April, A.D., 2013** as shown by the returns on file in the office of the Supervisor of Elections. We do hereby certify from said returns as follows:

In the **City of Gainesville Annexation Area 2 Election**, the whole number of votes cast was 613 for a 31.26% percent turnout, of which number:

FOR annexation described in Ordinance 120307 received 111 votes
AGAINST annexation described in Ordinance 120307 received 502 votes

In the **City of Gainesville Annexation Area 3 Election**, the whole number of votes cast was 54 for a 18.75% percent turnout, of which number:

FOR annexation described in Ordinance 120308 received 9 votes
AGAINST annexation described in Ordinance 120308 received 45 votes
