Discussion of Event Recycling (B)

Tom Strickland, Recycling Coordinator, gave a presentation. Members discussed.

Phil Mann, Interim Assistant City Manager, responded.

MOTION: 1) Staff begin working on event ordinance. Mandatory recycling and composting at events of a certain size on public property. Ask staff to bring information on event tiers/thresholds, 2) Banning sale of single-use plastics and Styrofoam at events, 3) Set May 2022 as a target timeline, 4) Set January 2023 as a target for "Zero Waste" events, and 4) Staff look into a

loan program for carts at events.

David Schwartz, Assistant City Attorney, recommended viewing events on City property differently from events on non-City property.
