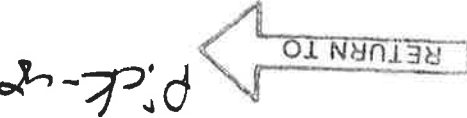

Lot 11, Block 3, Range 2, lying Northerly of the railroad right of way of ROPER'S ADDITION as per plat thereof recorded in Deed Book "J", page 550 of the public records of Alachua County, Florida.

TO HAVE AND TO HOLD the same together with all and singular the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title, interest, lien, equity and claim whatsoever of the said Grantor, either in law or equity, to the only proper use, benefit and behoof of the said Grantee forever.

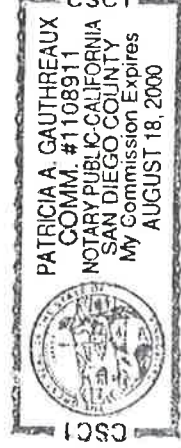
