An ordinance of the City of Gainesville, Florida; amending section 30-72(c) related to permitted uses in the agriculture district (AGR); reformatting the permitted uses into a table and creating and adding section 30-72(f) allowing outdoor gun ranges as a use by special use permit; providing conditions for the outdoor gun ranges; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.
