110492. Charter County and Regional Transportation System Surtax (B)

Section 212.055, Florida Statutes allows charter counties to impose a discretionary sales surtax of up to 1 percent. On September 20, 2011 the Alachua County Board of County Commissioners authorized County staff to proceed with development of a 2012 ballot initiative for a 1-cent Charter County Transportation System Surtax for a period of at least ten years and to begin discussions with the City of Gainesville and other cities and to begin the community involvement process.

Assistant City Manager Paul Folkers, Alachua County Engineer Dave Cerlanek, Public Works Director Richard Hedrick and RTS Director Jesus Gomez gave presentations.

MOTION: 1) Adopt the project list as presented and forward to the County; and 2) recommend to the County that the term of the surtax be 15 years.
