3.3 Analyze the availability and accessibility of child and youth programs and identify a role for City Government including addressing the harmful effects of child and youth poverty.

3.4 Facilitate broader community support to improve the educational opportunities for City youth.

Background

In April 2010 the Gainesville City Commission adopted the Gainesville Enrichment Mentoring (GEM) program in partnership with the Take Stock in Children Program. This partnership resulted in the purchase of 14 academic scholarships and a City employee mentoring initiative. In September 2010 the City Commission referred item number 100340 *Report on Low Socio-Economic Families* to the city's Equal Opportunity Committee. In March 2011 Dr. J. Kate Stowell presented a report on the specific condition of children in Gainesville to the City Commission. As a result of that report the City Commission requested that the EO Officer and the City Manager identify tangible next steps and funding within 90 days to begin implementation of the items discussed in the Stowell report.

As a part of the 2011-2012 budget the Gainesville City Commission approved funding for a part-time (30-hrs weekly) staff person providing professional administrative services to the City of Gainesville focused on the City of Gainesville Strategic Plan Initiatives #3.3 and #3.4 as it relates to improving the quality of life and educational opportunities for the City's children and youth. The position involves co-ordination of the City's efforts in these areas and extensive involvement with community partners and youth advocates.

Staffing Action Taken:

The above referenced position was filled in September 2011. This report outlines the status of initiatives within #3.3, and #3.4
