I am writing in support of the City of Gainesville's Site Specific Activities (SSA) application for the former Rinker/CSX property. This property is part of the Depot Park project, a much-anticipated brownfield rehabilitation initiative that will restore contaminated real property as a stormwater treatment facility and urban parkland.

SSA assistance for the former Rinker/CSX site will help the Depot Avenue neighborhood move beyond the stigma of contamination to a future ripe with possibilities. The environmental impacts, while relatively low risk, need to be addressed in order to integrate this site with an adjacent tract designated for use as a public park. Once the contamination is addressed, the site will become part of the park which will help mitigate urban stormwater impacts that currently affect downstream aquatic systems linked to the Floridan Aquifer. The restoration plan also includes the creation of scenic walking trails, bike paths and native greenery for public enjoyment.

This transformation, aided by SSA assistance, will ultimately enhance the quality of life for people living in the surrounding residential neighborhoods and will also strengthen the economic future of downtown Gainesville.
