28	March 6, 2007; and, pursuant to section 9-2 of the Code of Ordinances, the date of the		
29	run-off election, if necessary, shall be March 27, 2007.

2	invalid or unconstitutional by any court of competent jurisdiction, then said holding shall		
3	in no way affect the validity of the remaining portions of this ordinance.

5	extent of such conflict hereby repealed.		
6	Section 4. This ordinance shall become effective immediately upon final
