#### DISCUSSION OF PENDING REFERRALS

<u>130679.</u> E-Cig and Clean Air (B)

Explanation: On December 10, 2013, the County Commission adopted an ordinance regulating e-cigarettes. The ordinance prohibits three things:
1. sale of e-cigarettes to minors; 2. use of e-cigarettes at locations where smoking prohibited; and 3. sale of e-cigarettes through self-service merchandizing.

The ordinance will apply in the unincorporated area of Alachua County effective on July 1, 2014.

Staff has arranged for Kathy Nichols, Assistant Director, UF Area Health Education Centers Program to provide a presentation on the subject as she did for the County Commission. Staff from Alachua County Government and the Alachua County Health Department have also been invited to attend the February 26 PSC meeting.
