

Ordinance 060428
0-06-88

An ordinance of the City of Gainesville relating to Section 17-32 by removing Wacahoota Archery Range and Park from and adding Spring Hill Park and Woodlawn Park to the list of parks within the city limits which prohibit child sexual offenders and predators from living within 2,500 feet of the park; providing directions to the codifier; providing a severability clause; providing a repealing clause and providing an immediate effective date.

WHEREAS, at least 10 days notice has been given once by publication in a newspaper of general circulation notifying the public of this proposed ordinance and of a Public Hearing in the City Commission Auditorium in City Hall, City of Gainesville; and

WHEREAS, a Public Hearing was held pursuant to the published notice described at which hearing the parties in interest and all others had an opportunity to be and were, in fact, heard;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA;

Section 1. Section 17-32 of the Code of Ordinances of the City of Gainesville, is amended to read as follows:

Sec. 17-32. Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this article, except where the context clearly indicates a different meaning:

Day care center means a day care center as defined in section 30-23.

12 *Permanent residence* means a place where the person abides, lodges or resides for a
13 period of 14 or more consecutive days.

14 *Property owner* means the owner of record of the property and, for purposes of this
15 article, shall include any person, business or corporation with authority to let or rent the
16 premises.

17 *School* means a public or private elementary school, middle school, or secondary school.

18 *Temporary residence* means a place where the person abides, lodges or resides for a
19 period of 14 or more days in the aggregate during any calendar year and which is not the person's
20 permanent address, or a place where the person routinely abides, lodges or resides for a period of
21 four or more consecutive or nonconsecutive days in any month and which is not the person's
22 permanent address.

1 **Section 2.** It is the intention of the City Commission that Section 1 of this ordinance shall
2 become and be made a part of the Gainesville Code of Ordinance, of the City of Gainesville,
3 Florida, and that the Sections and Paragraphs of this ordinance may be renumbered or relettered in
4 order to accomplish such intentions.

5 **Section 3.** If any section, sentence, clause or phrase of this ordinance is held to be invalid or
6 unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the
7 validity of the remaining portions of this ordinance.

8 **Section 4.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of
9 such conflict hereby repealed.

10 **Section 5.** This ordinance shall become effective immediately on adoption
