RELEASE OF EASEMENT

WHEREAS, the purpose of this Release of Easement is to release the GRANTOR's interests in the Drainage and Utility Easement as per the plat of Colclough Hill Unit No. 2, recorded in Plat Book G, page 60 of the Public Records of Alachua County, Florida.

WITNESSETH, That the GRANTOR, for and in consideration of the benefits flowing to the City from improvement of the referenced property, does hereby remise and release forever, all the right, title, interest, claim and demand which the City has by virtue of the above-described easement in and to the following described lot, piece or parcel of land, situated, lying and being in the County of Alachua, State of Florida, to wit:

Commence at the Northeast corner of Lot Ten (10) of Colclough Hill, Unit No. 2, a Subdivision as recorded in Plat Book "G", page 60, of the public records of Alachua County, Florida; thence run North 40° 08' 40" West a distance of 10 feet to the Point of beginning; thence run North 40° 08' 40" West a distance of 285'; thence run South 49° 51' 20" West a distance of 10'; thence run South 40° 08' 40" East a distance of 285'; thence run North 49° 51' 20" East a distance of 10' to the point of beginning.

TO HAVE AND TO HOLD the same together with all and singular the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title, interest, lien, equity and claim whatsoever of the said Grantor, either in law or equity, to the only proper use, benefit and behoof of the said Grantee forever.
