## COMPLAINT

COMES NOW the Plaintiff, PHILLIP MICHAEL JONES, and sues Defendant, CITY OF GAINESVILLE FLORIDA, and in support thereof alleges as follows:

- This is an action for damages that exceed FIFTEEN THOUSAND DOLLARS (\$15,000.00), exclusive of costs and attorney's fees.
- At all times relevant to this action, Defendant CITY owned and operated a 2. Regional Transit System (RTS) Bus at or around 6419 West Newberry Road, Gainesville, Florida.
- 3. On or about November 15, 2011, the Plaintiff, PHILLIP MICHAEL JONES was sitting on a bench in the bus stop area at or around 6419 West Newberry Road, Gainesville, Florida.
- On that same date and time, Defendant CITY OF GAINESVILLE'S bus struck the bench occupied by Plaintiff PHILLIP MICHAEL JONES.
- 5. As a result, the Plaintiff PHILLIPMICHAEL JONES suffered bodily injury, including permanent injury to the body as a whole within a reasonable degree of medical probability, pain and suffering of both a physical and mental nature, disability, physical impairment, disfigurement, mental anguish, inconvenience, loss of capacity for the enjoyment of life, expense of medical and

nursing care and treatment, and loss of ability to lead and enjoy a normal life. These losses are either permanent or continuing, and the Plaintiff will suffer these losses in the future.

WHEREFORE, Plaintiff PHILLIP MICHAEL JONES demands judgment against Defendant, THE CITY OF GAINESVILLE, FLORIDA, a municipal corporation, in excess of FIFTEEN THOUSAND DOLLARS (\$15,000.00), plus interest, costs and such other relief as this Court may deem just and proper under the circumstances, and a trial by jury of all issues so triable.
