

Summary of the City Commission Meeting of January 9, 2006

#050790 City Commission Special Meeting – Santa Fe Community College and Tidewater Community College – the City Commission approved holding a joint meeting with Santa Fe Community College and Tidewater Community College on February 20, 2006. All members of the Leadership Team are invited to this meeting.

#050801 Appendix A Amendment, #050420 Public recreation Board Name Change, and #050530 Booting Fees for Unpaid Parking Tickets – the City Commission approved the Ordinances on the 1st Reading.

#041138 Hogtown Creek Charter Amendment – the City Commission approved the Ordinance on the 2nd Reading.

#050759 Single Lot Replat, Portofino Cluster Development Phase I, Lot 27 – the City Commission adopted the Resolution.

#050783 Gainesville Urban Reserve Area Update - the City Commission received an update on the Urban Reserve Area, and on the County's process to revise the Urban Reserve Area for each municipality. The Commission moved to endorse staff's position to convey to the County that the City is willing to retain NW 93rd Avenue within the City's Urban Reserve Area. The City Commission also requested that the County Commission respect the desires of the majority of the residents for their preferred Urban Reserve Area. The City Manager was directed to attend the January 10, 2006 County Commission meeting to present this position.

#050822 Fundraiser for Drunk Driving Intervention Program - during Citizen Comment, Jared Gaeger of the BUZZ Radio Station (313-3143) expressed BUZZ's intention to hold a fundraiser in the fall of 2006 to raise money to provide free cab rides to individuals who have had too much to drink. The City Commission referred this issue to the City Manager, with a report due back to the Commission by July 9, 2006. Chief Botsford, please have one of your staff members contact Mr. Gaeger to identify potential City coordination on this event, and presentation of a report to the Public Safety Committee. Mr. Gaeger suggested that it might be helpful if the City would hold the money that is collected in a secure account, ensuring individuals who donate money that the funds will be spent in an appropriate manner. Mr. Gaeger may also want to coordinate with the City on publicity for the event.
