

9/11 FACT SHEET

What occurred on September 11th, 2001 is a matter of facts, science and physics that all fail to support the government's version of what happened on 9/11/2001.

The FBI has never indicted Osama Bin Laden for 9/11 because they have no evidence. But the Media, government officials and political candidates continue to speak as if Bin Laden had already been "convicted" for the 9/11 attacks.

Marvin P. Bush, the president's younger brother, was a principal in a company called Securacom that provided security for the **World Trade Center**, United Airlines, and Dulles Airport. Securacom had an ongoing contract to handle security at the World Trade Center "**up to the day the buildings fell down.**"

Enormous profits were made by nameless insiders on plummeting stock prices of the two airlines involved in 9/11—American and United. Unbelievably, Bush supported a technicality of Federal law that served to protect the identities of traders who could be called as witnesses to an operation of mass murder and property destruction.
