13 14	WHEREAS, Resolution No. 080712 and Resolution 080713, adopted by the City		
15	Commission of the City of Gainesville on January 15, 2009, found certain areas (Study		
16	Area 1 and Study Area 2) adjacent to the Eastside Community Redevelopment Area to be		
17	blighted areas; and		
18	WHEREAS, the City Commission of the City of Gainesville has received the		
19	recommendation of the Gainesville Community Redevelopment Agency (CRA) to adopt		
20	the amended Eastside Community Redevelopment Plan (Plan), which expands the		
21	Eastside Community Redevelopment Area to include Study Area 1 and Study Area 2, and		
22	extends the time to accomplish the Plan, and has caused a public notice to be published		
23	and a notice mailed to each taxing authority as required by Section 163.346, Florida		
24	Statutes, and a public hearing was noticed, scheduled and held as required by Section		
25	163.361, Florida Statutes; and		
26	WHEREAS, the Plan focuses on the systemic changes needed to support		
27	redevelopment and reinvestment within the Eastside Community Redevelopment Area.		
28	The Plan includes objectives and initiatives to further redevelop and remove blight from		
29	the existing Community Redevelopment Area as well as from Study Area 1 and Study		
30	Area 2 Redevelopment objectives and initiatives outlined in the Plan focus on strategies		

- for economic development, commercial activity, housing, infrastructure, urban form,
- 2 sustainability, sense of community, and funding/financing/management/promotion.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
- 4 THE CITY OF GAINESVILLE, FLORIDA:
- 5 **Section 1.** Findings. Based on information presented to it, the City Commission
- 6 does hereby find:
- 7 (a) The recitals set forth above are hereby adopted and incorporated herein to
- 8 the full extent as if set forth in the text of this Resolution;
- 9 (b) The public hearing required by Section 163.361, Florida Statutes, has been
- 10 held and closed;
- 11 (c) A feasible method exists for the location of families who will be displaced
- from the community redevelopment area in decent, safe, and sanitary dwelling
- accommodations within their means and without undue hardship to such families;
- 14 (d) The Plan conforms to the general plan of the City of Gainesville as a
- 15 whole
- 16 (e) The modification of the Plan conforms to and complies with the
- 17 requirements of the Redevelopment Act;
- 18 (f) The Plan gives due consideration to the utilization of community policing
- innovations, and to the provision of adequate park and recreational areas and facilities
- 20 that may be desirable for neighborhood improvement, with special consideration for the
- 21 health, safety, and welfare of children residing in the general vicinity of the
- 22 redevelopment area;
- 23 (g) The Plan will afford maximum opportunity, consistent with the sound

needs of the City of Gainesville as a whole, for the rehabilitation or redevelopment of the		
community redevelopment area;		
Section 2. Adoption of the modification to the Plan. The Community		
Redevelopment Plan for the Eastside Community Redevelopment Area (Plan) attached as		
Exhibit 1, is approved and adopted. This Plan replaces and supersedes all prior and		
adopted plans, as of the effective date.		
Section 3. This resolution shall take effect immediately upon adoption.
