Appendix J - Public Street Light Policy Survey, Fall 2004

Public Street Light Policy Survey, Fall 2004

Clay Electric County street lights owned by Clay, monthly usage charged directly to the county

Individuals have rental lights billed to them.

Developers may request street lights in new subdivisions, and those are paid for

in the rates charged to residents of the subdivision.

JEA No city/county distinction. Public street lights all billed to the city, not in

base rates. No franchise fees or surcharges to franchise areas like Baldwin

or Atlantic Beach. JEA sends the city one bill for street lights.

Lakeland Electric City's streetlights are included in GFT (\$3 million of \$21 million transfer).

Polk County is billed directly by LE and pays bill

Outside the city, also Lighting Districts and the residents are charged on their tax bill.

Tallahassee Only service inside city, and bill the city directly. Public streetlights not built into

rates for base rates.

KUA bills city and county directly for poles used in given areas. Nothing in base

street lights.

There is a surcharge of 6% for streetlights outside the city limits, same as other

electric classes.

OUC Bills the City directly for Street lights in the Incorporated Area. In the

Unincorporated areas, OUC Bills the County and the County bills the residents for the street lights as part of their Taxes. The County has set up MSTU (Municipal Street Light Taxing Units), the basis they charge the residents for the street lights, and this is the same charge that OUC bills to the county; thus the streetlight charges are passed through

the county to the residents.

Also have subdivisions that were set up under agreements several years ago, where the

residents are billed by OUC for their share of their neighborhood street lights. They are

no longer creating accounts this way, but continue the old agreements.
