Denial of CARES Funding by Alachua County (B)

Explanation: Alachua County indicated that they would be reallocating remaining Federal CARES funding (pass-through by the State of Florida) for a category entitled Presumptive Public Safety.

The City submitted documentation to Alachua County of approximately \$2.6 million for this category. This allocation was included in the schedule of uses of funds in the backup to the agenda item (see attached). The final action of the County Commission removed that allocation and placed it in the County's Designated Reserves/Fund Balance (see attached). Communication with the County indicated that the City of Gainesville money was being set aside for future board needs because of the trunk radio system issue with GRU. The County chose to continue to fund the City of Alachua and the City of High Springs.
