QUIT-CLAIM DEED

THIS QUIT-CLAIM DEED, executed this _____ day of ______, 2007, by the CITY OF GAINESVILLE, a municipal corporation of the State of Florida, Grantor, to GAINESVILLE FORD, Inc., a Florida Corporation, Grantee:

WITNESSETH, That the said Grantor, for and in consideration of the sum of one (\$1.00) dollar and other good and valuable consideration to it in hand paid by the said Grantee, the receipt whereof is hereby acknowledged, does hereby remise, release and quit-claim unto the said Grantee forever, all the right, title, interest, claim and demand which the said Grantor has in and to the following described lot, piece or parcel of land, situated, lying and being in the County of Alachua, State of Florida, to wit:

Commence at the Northeast corner of Section 28-T9S-R20E and run S 89°09'36"W along the North line of said Section 3411.06 feet, thence S 01°03'22"E 1943.00 feet to the Point of Beginning; thence continue S 01° 03'22"E 357.81 feet, thence S 89°22'21" W 850.02 feet to the East R/W of State Road No. 329, thence N 01°03'22"W 354.74 feet, thence N 89°09'36"E 850.00 feet to the POB. (Being further described as the Southerly portion of Lot #1, North Main Street Commercial Park, PB H-96, Public Records). All lying and being in the northwest quarter of Section 28-T9S-R20E, Alachua County, Florida.
