

**Amendment to Interlocal Agreement
Between
The City of Gainesville and The University of Florida
For
Bicycle/Pedestrian Facility Construction**

This Agreement is made by and between the UNIVERSITY OF FLORIDA, for and on behalf of the Board of Trustees of the State of Florida, a public corporation of the State of Florida, (hereinafter referred to as UF), and the CITY OF GAINESVILLE, FLORIDA, a municipal corporation, (hereinafter referred to as CITY), by and through its City Commission.

WHEREAS, the UF prepared and adopted a campus master plan for the University of Florida in compliance with the requirements set forth in Subsections 240.155(3)-(6), Florida Statutes, and

WHEREAS, upon adoption of the campus master plan the CITY and UF entered into a campus development agreement, and

WHEREAS, the campus development agreement required UF to provide the CITY with \$1,000,000 for bicycle and pedestrian facility improvements, and UF has given these funds to the CITY, and

WHEREAS, the CITY and UF entered into an agreement to provide \$360,000 of these funds to UF for the construction of certain bicycle/pedestrian projects, and

WHEREAS, UF has updated the construction cost estimates of one of those certain projects and has determined that an additional \$100,000 will be required to construct these facilities, and

WHEREAS, the CITY and UF have agreed that an additional \$100,000 of these funds should be allocated for the certain bicycle/pedestrian projects.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree to amend the Interlocal Agreement for Bicycle/Pedestrian Facility Construction as follows:

- I. Subsection I.1. is amended as follows:
 1. The City agrees to provide up to \$460,000 towards the construction of three bicycle/pedestrian facilities specified as follows:
 - a. A bicycle/pedestrian trail to connect the newly constructed Commuter Parking Lot on Hull Road Extension to Southwest 20th Avenue;
 - b. Pedestrian-level lighting along the west side of SW 13 Street from SW 8 Avenue to SW 4 Avenue; and

c. A bicycle/pedestrian trail to connect SW 10 Terrace to SW 11 Street across the P.K. Yonge site.

II. Subsection II.1. is amended as follows:

1. The UF agrees to accept and expend up to \$460,000 towards construction of the three bicycle/pedestrian facilities specified in Section 1.

III. Subsection III.1. is amended as follows:

1. All reimbursement will be based on itemized invoices submitted by the UF. The sum total of all invoices shall not exceed \$460,000.

IV. In all other respects the provisions of the Interlocal Agreement for Bicycle/Pedestrian Facility Construction remain unchanged.
