Regional Utilities Committee Outstanding Referral Status Report

Following is a list of each item and a brief description of the status of the referrals to the Regional Utilities Committee (RUC):

#### 1. #04240 - Fire Hydrant Fees:

This item was brought forward at the July 22, 2004 GRU budget presentation by Commissioner Braddy. The City Commission referred the issue of Fire Hydrant Fees to the Regional Utilities Committee. At the September 8, 2005 meeting the Committee agreed to send a recommendation to the full Commission to remove the Fire Hydrant Fee item from the RUC referral list and ask for a new referral to the RUC to review the issue of street lights.

### 2. #050168 - Rain Sensor Analysis:

On July 11, 2005 the City Commission referred the issue of analysis of rain sensors as a potential water and energy conservation source to the Regional Utilities Committee for review. At the September 8, 2005 the RUC received information from staff about the conservation programs that are in place. The RUC agreed to report back to the City Commission that GRU is currently engaged in identifying rain sensor technology as an important part of conservation and it is required by state law. GRU hosts annual meetings with irrigation contractors at which this information is provided. The Regional Utilities Committee recommends this item be removed from the referral list.

# 3. #050283 – GRUCom Video Services in Newberry & Gainesville:

On August 8, 2005 the City Commission referred the issue of the provision of video services within the City of Newberry and the City of Gainesville to the Regional Utilities Committee for review and a report back to the City Commission. At the September 8, 2005 meeting the RUC received information from staff regarding this referral. The RUC will retain this item in Committee for further review.

# 4. #031086 - Utilities Policies to Promote Residential Grid-Connected Solar Electric Systems (Mayor Tom Bussing):

At the March 29, 2004 City Commission meeting this issue was referred to the Regional Utilities Committee. This item will be retained in Committee for further review.
