As a result of this inquiry, we concluded that the actions of the officers as stated in your allegations did not occur. We sent a letter to you on 02-11-03 to inform you of our findings.

Your current complaint to Internal Affairs again deals with issues pertaining to your arrest and conviction for molesting children. We have already examined this issue and found no wrongdoing on the part of the officers. Based on our previous findings, we have determined that this matter does not warrant any further investigation. We consider this matter to be closed.
