	Tara Thomas gave a presentation on GRU's current programs designed to help low income customers. She focused on the LEEP program and explained what makes it a more cost effective program for GRU to administer as well as providing more benefit to low-income customers in terms of comfort and energy efficiency of their homes.
	Commissioner Poe asked staff to provide information on how much energy has been saved to date through the LEEP program. Commissioners Chase and Pinkoson asked for data on how many homes in Gainesville are potentially eligible to participate in LEEP.
	Staff does not recommend development of a program to assist low-income customers attain solar PV systems.
	Citizens Jim Konish and Nancy Deren spoke on this item.
	After hearing the next item, the Commitee voted to accept staff's recommendation and to recommend removal of this item from committee.
