## Local Option Fuel Tax

"Transportation expenditures needed to meet the requirements of the capital improvements element of an adopted comprehensive plan or for expenditures needed to meet immediate local transportation problems and for other transportation-related expenditures that are critical for building comprehensive roadway networks by local governments."

#### **Distribution of Revenue**

Statutes provide for the negotiation of an interlocal agreement between the county and the municipality representing the majority of population. The agreement is to define the revenue distribution formula. Absent an interlocal agreement state law provides a default formula that distributes the revenue based on transportation expenditures of the past five years as a proportion of the total of such expenditures of the county and each municipality.
