An ordinance amending the Zoning Map Atlas of the City of Gainesville, Florida, to correct the University Heights Historic District-North map by deleting an incorrect depiction of a contributing structure located at 1015 NW 3rd Avenue; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, Section 30-112 of the City of Gainesville Land Development Code provides provisions for the preservation and conservation of historic resources that are reminders of past eras, events and persons important in local, state or national history, or which provide significant examples of architectural styles of the past, or which are unique and irreplaceable assets to the city and its neighborhoods, or which provide examples of the physical surroundings in which past generations lived; and

WHEREAS, Section 30-112 of the Land Development Code effectuates this purpose by modifying the land development regulations set forth in the Land Development Code for buildings and structures that are either individually listed on the local register of historic places or located within and deemed a contributing structure to a historic district; and

WHEREAS, Subsection 30-112(d)(3) of the Land Development Code provides the procedure to individually list a building or structure on the local register of historic places or to deem a building or structure as contributing to a historic district, which shall include processing with the same procedures set forth in the Land Development Code for rezonings and recording the designation in the Public Records of Alachua County, Florida; and

WHEREAS, on January 14, 2002, the City Commission adopted Ordinance No. 001026, which established the University Heights Historic District-North and identified the contributing and noncontributing structures within the district; and

1	WHEREAS, City staff has determined that the map that was included with Ordinance
2	No. 001026 incorrectly identified that the property located at 1015 NW 3 rd Avenue contained
3	both a contributing and a noncontributing structure, whereas in fact the property has only a single
4	noncontributing structure; and
5	WHEREAS, this ordinance amends the Zoning Map Atlas of the City of Gainesville to
6	correct the University Heights Historic District-North map by deleting the incorrect depiction of
7	a contributing structure located at 1015 NW 3 rd Avenue; and
8	WHEREAS, the City Plan Board, which acts as the local planning agency pursuant to
9	Section 163.3174, Florida Statutes, held a public hearing on July 23, 2015, and voted to
10	recommend that the City Commission adopt this ordinance to correct the University Heights
11	Historic District-North map; and
12	WHEREAS, at least ten (10) days' notice has been given once by publication in a
13	newspaper of general circulation notifying the public of this proposed ordinance and of a public
14	hearing in the City Hall Auditorium located on the first floor of City Hall in the City of Gainesville;
15	and
16	WHEREAS, at least thirty (30) days' notice has been given by mail to the real property
17	owner(s) whose land will be redesignated by enactment of this ordinance and whose address is
18	known by reference to the latest ad valorem tax records, notifying such property owner(s) of this
19	proposed ordinance and of a public hearing in the City Hall Auditorium located on the first floor
20	of City Hall in the City of Gainesville; and
21	WHEREAS, the public hearing was held pursuant to the notice described above at which
22	hearing the parties in interest and all others had an opportunity to be and were, in fact, heard.
23	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE

CITY OF GAINESVILLE, FLORIDA:

2	Section 1. The Zoning Map Atlas of the City of Gainesville is amended to correct the				
3	University Heights Historic District-North map by deleting an incorrect depiction of a				
4	contributing structure located at 1015 NW 3 rd Avenue, as shown in Exhibit "A" attached to this				
5	ordinance and made a part hereof as if set forth in full.				
6	Section 2. The City Manager or designee is authorized and directed to make the				
7	necessary changes to the University Heights Historic District-North map to comply with this				
8	ordinance.				
9	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance				
10	or the application hereof to any person or circumstance is held invalid or unconstitutional, such				
11	finding shall not affect the other provisions or applications of this ordinance that can be given				
12	effect without the invalid or unconstitutional provision or application, and to this end the				
13	provisions of this ordinance are declared severable.				
14	Section 4. All ordinances or parts of ordinances in conflict herewith are to the extent of				
15	such conflict hereby repealed.				
16	Section 5. This ordinance shall become effective immediately upon adoption.
