17 1. The City Commission does hereby receive, accept and approve the report of the Board of  
18 Canvassers for the City of Gainesville, Florida, election held on March 16, 2010, which report shows that  
19 there will be a run-off election between Craig Lowe and Don Marsh, the two candidates who received the  
20 highest number of votes for Mayor; and that there will be a run-off election between Randolph Wells and  
21 Penny Wheat, the two candidates who received the highest number of votes for the District 4 Seat.

22 2. The Report of the Board of Canvassers for the City of Gainesville, Florida election held  
23 March 16, 2010, is attached and made part of this resolution by reference.

24 3. This Resolution shall become effective immediately upon adoption.
