2008 - 2009 SALARY SURVEY FOR CHARTER OFFICER: CITY ATTORNEY

For the City Attorney salary survey only jurisdictions recommended by the Gainesville City Attorney were included. These jurisdictions were included as comparable jurisdictions based on levels of service, number of employees, and size of the jurisdiction. The 2008 Florida Price Level Index (FPLI) and the populations are provided in Figure 1. Figure 2 contains the raw data for all surveyed jurisdictions. The bar charts represent the unadjusted (Figure 3) and adjusted (Figure 4) salaries.



The salary of the Gainesville City Attorney is \$8,626 below the median of the unadjusted salaries of surveyed City and County Attorneys.


