2 3 4 5 6 7 8 9		An ordinance of the City of Gainesville, Florida, creating section 28-19 of the City of Gainesville Code of Ordinances, by providing for a Taxi Service Bill of Rights and related requirements; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.	
10	W	HEREAS, at least 10 days notice has been given once by publication in a newspaper	
11	of genera	l circulation notifying the public of this proposed ordinance and of a public hearing to	
12	be held in the City Commission Auditorium, City Hall, City of Gainesville; and		
13	WHEREAS, the Public Hearings were held pursuant to the published notice described at		
14	which hearings the parties in interest and all others had an opportunity to be and were, in fact,		
15	heard.		
16	N	OW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE	
17	CITY OF GAINESVILLE, FLORIDA:		
18	Section 1. Section 28-19 of the Gainesville Code of Ordinances is created		
19	to read as follows:		
20	Sec.	28-19. – Taxi Service Bill of Rights.	
21	<u>(a)</u>	All taxicabs operated under the authority of this chapter shall have prominently	
22		posted in a location visible to a passenger seated in the passenger seats of the vehicle	
23		a "Taxi Service Bill of Rights", or a notice that a "Taxi Service Bill of Rights" will be	
24		provided immediately upon request. If the entire "Taxi Service Bill of Rights" is not	
25		posted, and the option for a notice advising that said document is available on request	
26		is utilized, the taxicab must have available cards or circulars with the full text of the	
27		"Taxi Service Bill of Rights". These cards or circulars must list in clear and legible	

28	<u>fashion ti</u>	ne full contents of the approved "Taxi Service Bill of Rights". The copies of
29	the "Taxi	Service Bill of Rights" to be distributed shall be made available from the
30	<u>City Mar</u>	nager or his or her designee, at a cost not to exceed the cost of production, or
31	may be re	eproduced by the franchise owner as long as the format and appearance of
32	said card	or circular have been filed with, and approved by, the City M anager or his
33	or her de	signee.
34	(b) This "Ta	xi Service Bill of Rights" shall be prepared by the City Manager, or his/her
35	<u>designee.</u>	and shall set forth the rights of taxicab passengers and taxicab drivers under
36	Florida S	tate Statutes and City of Gainesville Ordinances, and shall provide
37	additiona	Il information as to how to report violations. It may be changed from time to
38	time as c	hanges in law or ordinances require. Whenever the contents of the "Taxi
39	Service F	Bill of Rights" are changed, the franchise owners shall be provided notice at
40	least 30 c	days prior to the effective change in order to obtain or prepare copies for
41	distributi	on and posting.
42	Section 2.	It is the intention of the City Commission that the provisions of Section 1
43	shall become and be	e made a part of the Code of Ordinances of the City of Gainesville, Florida
44	and that the Sections	s and Paragraphs of this Ordinance may be renumbered or relettered in order
45	to accomplish such i	ntentions.
46	Section 3. If	f any section, sentence, clause or phrase of this ordinance is held to be
47	invalid or unconstitu	itional by any court of competent jurisdiction, then said holding shall in no
48	way affect the validi	ity of the remaining portions of this ordinance.
49	Section 4. A	all ordinances, or parts of ordinances, in conflict herewith are to the extent of
50	such conflict hereby	repealed.
