*PRESENTATIONS: Administrative Services Director Becky Rountree, Finance Director Mark Benton, RTS Director Jesus Gomez, Public Works, Director Teresa Scott, Parks Recreation, Cultural Affairs Director Steve Phillips, Assistant City Manager Paul Folkers gave presentations.*
