### NARRATIVE

On 6/29/2005 at approx. 1215 hrs. while on uniform patrol, I was requested by LT. Ash (092) to respond to 1226 NW 10th Ave. (Bread and Roses) to investigate a possible Battery on an employee by a protester.

Upon arrival, I contacted Stephens who works for the Bread and Roses clinic. Stephens advised that she was struck with a pamphlet by a protestor (later ID as Leto) outside the business. Stephens advised the clinic has on-going issues with the protestors harassing patients and staff members. Stephens advised that she and another employee(Harrison) exited the front door of the business for lunch break. While walking to the vehicles, Stephens attempted to take pictures of the protestors and their signs. Stephens advised that she took a photo from approx. 10-15 ft. from the subjects, then began to walk closer to take additional photos. Stephens advised that she then walked on the sidewalk, at which time Leto was walking parallel to her (looking at her). Stephens advised that she took a close up photo of Leto from approx. 3 to 4 ft. away. Stephens advised that approx. 5 secs. later, Leto put the pamphlet up to her face, which resulted in the pamphlet touching the right side of her head. Stephens advised that she could not be 100% sure(90% according to Stephens), if Leto intended to touch her with the pamphlet. Stephens later determined that she did not want anything criminally done to Leto, she just fears that this might happen to patients. No visible injuries to Stephens.

I then contacted Leto and read him his Miranda Warnings. Post-Miranda, Leto advised that he observed Stephens exit the clinic and take a picture of them from approx. 15 ft. away. Leto advised that he then bent down and turned his back to Stephens for several seconds. Leto advised that when turned around he was "startled" to see Stephens approx. 1 foot from him, with the camera in his face. Leto advised that being startled, he put the pamphlet up to protect himself. Leto advised that during this exchange, he brushed the pamphlet against Stephens hand and/or her camera. Leto denied intentionally striking Stephens at anytime.

I then contacted Wytko, Miranda and Berg who also protest outside the clinic with Leto. Each of their testimony supported to statements made by Leto that he was startled by Stephens.

I then contacted Harrison via telephone. Harrision supported the testimony of Stephens, that Leto did not have his back turned to Stephens as she approached. Harrison advised that the pamphlet did touch Stephens on the head.

Lt. Ash (092) responded. After discussing the incident details, it was determined that do to the conflicting testimonies of if the incident, whether it being intentional and deliberate, and Stephens' request for no criminal action being taken against Leto, this incident is documented as a disturbance per Lt. Ash.
