

Resolution No. 110120

**A Resolution of the City Commission of the City of
Gainesville, Florida, repealing Resolution No. 100884
and authorizing the City Manager to execute a Joint
Participation Agreement between the City of Gainesville
and the Florida Department of Transportation (FDOT)
to receive funding for the Bus Rapid Transit (BRT)
Alternatives Analysis Study.**

WHEREAS, the City of Gainesville owns and operates the public transit system serving the Gainesville urbanized area in Alachua County; and

WHEREAS, the Florida Department of Transportation (FDOT) makes available funding for transit projects every year; and

WHEREAS, the Florida Department of Transportation requires the execution of a Joint Participation Agreement by the City with no local matching funds for the Bus Rapid Transit (BRT) Alternatives Analysis; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including provision of the local share of the project costs; and

WHEREAS, the Florida Department of Transportation (FDOT) requires the governing board of each public transit system to adopt a resolution authorizing the acceptance of these funds.

WHEREAS, the City Commission adopted Resolution No. 100884 on May 5, 2011 authorizing the City Manager to execute a Supplemental Joint Participation Agreement between the City of Gainesville and the Florida Department of Transportation;

WHEREAS, the Florida Department of Transportation has subsequently returned the unexecuted Supplemental Agreement and has requested the City to amend the Supplemental Joint Participation Agreement to a Joint Participation Agreement, as well as the accompanying resolution.


WHEREAS, it is necessary to repeal Resolution No. 100884 based upon the State's request.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:


1. That the City Commission repeals Resolution No. 100884.
2. That the City Manager or his designee is authorized to execute a Joint Participation Agreement between the City of Gainesville and the Florida Department of Transportation (FDOT) to accept the allocation for the City of Gainesville for the provision of transit services for the Bus Rapid Transit (BRT) Alternatives Study.
3. That the City Manager or his authorized designee is authorized to execute the Joint Participation Agreement (JPA) including any Supplemental Joint Participation Agreements (SJPA) for the purpose of Scope Changes and/or funding adjustments, as well as execute Assurances, Certifications, and all other documents as may be required in support of the project.

4. That the City Manager or his authorized designee is authorized to sign requests for Contract Time Extension(s), as may be required in support of the project.
5. That the City Manager, within the City's approved budget, is authorized to provide the local share to match such grant funds as may be required.
6. This Resolution shall become effective immediately upon adoption.


