An ordinance of the City of Gainesville, Florida, correcting a scrivener's error by adding tax parcel number 06687-004-000 to the title and Section 1 of Ordinance No. 070130, which was adopted on August 27, 2007; and providing an immediate effective date.

**WHEREAS**, on August 27, 2007 the City Commission adopted Ordinance No. 070130; and

**WHEREAS**, Ordinance No. 070130, as adopted, contained a scrivener's error in the title and Section 1 of said ordinance, which can only be corrected by ordinance; and

**WHEREAS**, pursuant to law, at least ten days notice has been given prior to adoption by publication in a newspaper of general circulation notifying the public of this proposed Ordinance and of a Public Hearing to be held in the City Commission meeting room, First Floor, City Hall, in the City of Gainesville; and

**WHEREAS**, Public Hearings were held pursuant to law, at which hearings the parties in interest and all others had an opportunity to be and were, in fact heard.

**WHEREAS**, the Public Hearings were held pursuant to the published notice described at which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:**

**Section 1.** The title of Ordinance No. 070130 is amended as follows:

“An Ordinance of the City of Gainesville, Florida; adopting an Urban Services Report which sets forth the plans to provide urban services to an area comprised of Tax Parcels 06687-000-000, 06687-003-000, 06687-004-000, 06687-005-000, and 06687-006-000,

06687-007-000, and 06686-000-000, generally located south of the vicinity of SW 20<sup>th</sup> Avenue, west of SW 43rd Street, north of SW 24<sup>th</sup> Avenue, and east of the City Limits and the vicinity of Interstate 75; the area is proposed for annexation by the City of Gainesville pursuant to Chapter 90-496, Special Act, Laws of Florida, as amended, known as the Alachua County Boundary Adjustment Act; providing directions to the City Manager, the City Attorney and the Clerk of the Commission; providing a repealing clause; providing a severability clause; and providing an immediate effective date.”

**Section 2.** Section 1 of Ordinance No. 070130 is amended as follows:

“The Urban Services Report, a copy of which is attached as Exhibit "A" and incorporated herein as if set forth in full, sets forth the plans to provide urban services to an area comprised of Tax Parcels 06687-000-000, 06687-003-000, 06687-004-000, 06687-005-000, and 06687-006-000, 06687-007-000, and 06686-000-000, generally located south of the vicinity of SW 20<sup>th</sup> Avenue, west of SW 43rd Street, north of SW 24<sup>th</sup> Avenue, and east of the City Limits and the vicinity of Interstate 75, and is hereby approved and adopted for that certain area as more specifically described in the Urban Services Report.”

**Section 3.** The City Manager is directed to file a copy of this Ordinance with the Board of County Commissioners of Alachua County and to send a copy to the owner of Tax Parcel No. 06687-004-000.

**Section 4.** Except as amended herein, Ordinance No. 070130 shall remain in full force and effect.

**Section 5.** This Ordinance shall become effective immediately upon adoption.
