5 A resolution of the City Commission of the City of Gainesville,
6 Florida, amending and establishing maximum rates for parking
7 meters, parking lots and parking garages in accordance with Chapter
8 26, Division 2 of the Code of Ordinances of the City of Gainesville,
9 Florida; directing the City Manager to establish rates at the
10 maximum rate; providing a repealing clause; and providing an
11 immediate effective date.

14 **WHEREAS**, Chapter 26, Division 2 of the Code of Ordinances of the City of Gainesville
15 provides that parking rates for parking meters, parking lots and parking garages be established by
16 resolution of the City Commission.
17

18 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE**
19 **CITY OF GAINESVILLE, FLORIDA:**
20

21 **Section 1.** The City Commission finds that the following categories of on-street and
22 parking lot parking require the deposit in parking meters of coin or coins or payment by other
23 mode of payment compatible with the technology of the parking meter:
24

- 25 (1) Short term metered zones, not exceeding 4 hours, hourly rate \$0.50.
26 (2) Long term metered zones, in excess of 4 hours, hourly rate \$0.25.

27 **Section 2.** The City Commission finds that payment for garage parking requires payment
28 by mode compatible with the technology of the parking equipment installed in the garage. The
29 following categories and maximum rates are established for garage parking:
30

31 Daytime (6:00 A.M. to 6:00 P.M.)

- 32 (1) Hourly fee for first 6 hours \$1.00/hour
33 (2) Over 6 hours \$6.00
34 Lost Ticket..... \$6.00
35

36 Nighttime (6:00 P.M to 6:00 A.M.)

- 37 (1) Nightly flat rate \$5.00
38 (2) Lost Ticket \$6.00

40 Special Event (Event designated by City Manager)

- 41 Daily flat rate \$5.00

3 Contract Parking
4

5 One month\$ 40.00
6 Three (3) months advance purchase\$ 114.00
7 Six (6) months advance purchase\$ 216.00
8 Twelve (12) months advance purchase\$ 420.00
9

10 Access cards for contract parking have unlimited access to the garage (24 hours/7 days
11 per week) including access during special events.
12 Access cards may be paid for on a quarterly basis.
13

14 **Section 3.** The City Manager is directed to establish rates at the maximum.
15

16 **Section 4.** All resolutions, or parts of resolutions, in conflict herewith are to the extent of
17 such conflict hereby repealed.
18

19 **Section 5.** This resolution shall take effect immediately upon adoption.
