ORDINANCE NO. 1

An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain properties from the zoning category of "I-1: Limited industrial district" to "BI: Business industrial district"; consisting of approximately 61.37 acres, and generally bounded on the North by N.E. 39th Avenue, bounded on the East by Waldo Road (S.R. 24), bounded on the South by N.E. 23rd Avenue, and bounded on the West by N.E. 21st Way and N.E. 15th Terrace; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, publication of notice of a public hearing was given that the Zoning Map Atlas be amended by rezoning certain properties from the zoning category of "I-1: Limited industrial district" to "BI: Business industrial district"; and

WHEREAS, notice was given and publication made as required by law and a public hearing was held by the City Plan Board on December 5, 2011; and

WHEREAS, the City Commission finds that the rezoning of the property described herein will be consistent with the City of Gainesville Comprehensive Plan; and

WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches long was placed in a newspaper of general circulation and of the public hearing to be held in the City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven (7)

days after the day the first advertisement was published; and

1	WHEREAS, a second advertisement no less than two columns wide by 10 inches long was			
2	placed in the aforesaid newspaper notifying the public of the second public hearing to be held at the			
3	adoption stage at least five (5) days after the day the second advertisement was published; and			
4	WHEREAS, Public Hearings were held pursuant to the published and mailed notices			
5	described above at which hearings the parties in interest and all others had an opportunity to be and			
6	were, in fact, heard.			
7	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE			
8	CITY OF GAINESVILLE, FLORIDA:			
9	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning			
10	certain properties from the zoning category of "I-1: Limited industrial district" to "BI: Business			
11	industrial district", as more specifically described below:			
12 13	See map attached hereto as Exhibit "1" and made a part hereof as if set forth in full.			
14 15	Section 2. The City Manager is authorized and directed to make the necessary changes			
16	in the Zoning Map to comply with this Ordinance.			
17	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance			
18	or the application hereof to any person or circumstance is held invalid or unconstitutional, such			
19	finding shall not affect the other provisions or applications of the ordinance which can be given			
20	effect without the invalid or unconstitutional provisions or application, and to this end the			
21	provisions of this ordinance are declared severable.			
22	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
