RENEWAL OF THE INTERLOCAL AGREEMENT FOR TRAFFIC ENGINEERING SERVICES

THIS RENEWAL is entered into by and between THE CITY OF GAINESVILLE, FLORIDA, a municipal corporation (hereinafter referred to as "CITY"), and ALACHUA COUNTY, a charter and political subdivision of the State of Florida, by and through its Board of County Commissioners (hereinafter referred to as "COUNTY").

WHEREAS, the CITY and COUNTY have previously entered into an Interlocal Agreement for Traffic Engineering Services effective October 1, 2008 (the "Agreement") and;

WHEREAS, Section 1 of the Agreement provides for automatic annual renewals of the Agreement, until amended or terminated; and

WHEREAS, the CITY and COUNTY desire to memorialize in writing their intent to renew and amend the Agreement;

NOW, THEREFORE, the parties agree as follows:

- 1. The CITY and COUNTY hereby renew the Agreement, effective October 1, 2011.
- 2. Effective October 1, 2011, the CITY and COUNTY agree to the Service Locations and Extraordinary Repairs or Services set forth in Attachments A (2011/2012) & B (2011/2012) respectively.
- 3. Effective October 1, 2011, The CITY and COUNTY agree to the costs and charges set forth in Attachment C (2011/2012).
- 4. Attachments A (2011/2012), B (2011/2012), and C (2011/2012) are attached to this Renewal and made a part hereof. These Attachments supercede the previous attachment in the Agreement.
- 5. This Renewal shall inure to the benefit of and be binding on both the CITY and COUNTY.
- 6. Except as amended herein (the terms of which shall govern in the event of conflict or inconsistency with any prior document), the terms and conditions of the Agreement remain in full force and effect.

ATTACHMENT B (2011/2012) – EXTRAORDINARY REPAIRS

The activities listed below, but not limited to those below, are defined as extraordinary repair activities requiring the use of specialized or heavy equipment the City Traffic Operations Section may not have readily available:

- Re-spanning overhead span or messenger wire and supporting materials
- Rewiring overhead messenger wire
- Replacing concrete controller pads
- Reworking or repairing underground conduit and cables
- Re-installation of poles supporting traffic signal, flashing school beacon and flashing warning beacon installations
- Specification, design, ordering and purchasing of special equipment (non off-the-shelf items)
- Repainting of mast arms and poles
- Structural repairs of mast arms and poles

Extraordinary repair activities would also include repairs required as a result of severe weather, including but not limited to tornadoes, hurricanes and windstorms.

The determination of whether a repair activity is extraordinary or not will be made by the City's Traffic Operations Manager, or designee, once all aspects of the repairs are determined.

ATTACHMENT C (2011/2012) CITY-COUNTY TRAFFIC ENGINEERING SERVICES AGREEMENT FY 2011/2012 COST DETERMINATION FOR PREVENTATIVE SIGNAL MAINTENANCE & ROUTINE REPAIR

Cost for FY 2011-12

The CPI increase for **2010** was 1.5%.

Signal Cost(\$4,017.11) times (1.015) = \$4,077.37TMS Cost per Signal(\$980.92) times (1.015) = \$995.63Total Cost per Signal(\$4,077.37) plus (\$995.63) = \$5,073.00The cost for thirty-seven (37) signals will be:
(\$5,073.00) times (37) = \$187,701.00.The monthly cost the County will pay the City is \$187,701.00 divided by 12 = \$15,641.75 per month

This cost includes preventative maintenance and routine repair for traffic signals, flashing school beacons, flashing warning beacons and the Traffic Management System.
